Introduction

The Bank of Tanzania Academy (BOT-Academy) previously known as Bank of Tanzania Training Institute (BOT-TI) was established in 1991 as one of the operational units of the Bank of Tanzania (BOT) mandated to provide short term capacity building training programmes to staff of BOT and financial institutions, mainly focusing on achievement of the objectives of BOT. Training programmes were further expanded to cater for regional central banks' arrangements in the East African Community (EAC) and the Southern African Development Community (SADC).

Despite the provision of short courses, financial institutions in the country have been facing numerous challenges, including existence of gaps in ethics and professionalism. The BOT-Academy has endeavoured to address these gaps through provision of long-term competence-based trainina. The objective being to strengthen the role of the Academy to effectively support the achievement of the Bank's Vision and Mission in a broader sense. Therefore. the Academy intends to strengthen and leverage the supervisory role of the Bank of Tanzania beyond the legal and

regulatory compliance aspects and instill ethical and professional practices in the financial sector.

Programmes offered

The Bank of Tanzania Academy has been registered and accredited by the National Council for Technical and Vocational Education Training (NACTVET). It offers programmes which are competencebased intending to build professionals from early stages in the banking career, where an appropriate culture rooted in integrity, honesty and professionalism can be moulded. The programme is targeted to address the training needs of staff of financial institutions and individuals who aspire to work in the financial sector.

In line with the above stated objectives, the Principal of the BOT Academy cordially invites suitable candidates to apply into:

- Ordinary Diploma in Banking Practice and Supervision
- Postgraduate Diploma in Banking Management.

Ordinary Diploma Duration

The Ordinary Diploma in Banking Practice and Supervision (ODBPS) is undertaken in two years:

- 1st Year: Technician Certificate in Banking Practice and Supervision (NTA Level 5) and
- 2nd Year Ordinary Diploma in Banking Practice and Supervision (NTA Level 6)

Entry requirements

The minimum entry Requirements to the Technician Certificate in Banking Practice and Superversion are:

- a) Possession of the National Technical Award (NTA) Level 4 in any of the following; Banking, Accounting, Finance, Marketing, Procurement, Human Resource, Information Technology and Business Administration from institutions recognized by NACTVET
- b) Possession of at least one (1) principal pass and one (1) subsidiary pass in any subject in the Advanced Certificate

of Secondary Education Examination (ACSEE) and four passes in nonreligious subjects in the Certificate of Secondary Education Examination (CSEE).

Postgraduate Diploma Duration

The Postgraduate Diploma in Banking Management (PGDBM) is offered in one academic year comprised of two semesters.

Entry Requirements

Any bachelor's degree from a recognized higher learning institution
